

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.millennialdestinations.com and Millennial Destinations, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Millennial Destinations, LLC include www.millennialdestinations.com and Millennial Destinations. The Millennial Destinations website is a Passive (information only display) site. By using the Millennial Destinations website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Millennial Destinations may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Millennial Destinations public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Millennial Destinations collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Millennial Destinations may also use your personally identifiable information to inform you of other products or services available from Millennial Destinations and its affiliates.

Sharing Information with Third Parties

Millennial Destinations does not sell, rent or lease its customer lists to third parties.

Millennial Destinations may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Millennial Destinations may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Millennial Destinations, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Millennial Destinations may keep track of the websites and pages our users visit within Millennial Destinations, in order to determine what Millennial Destinations services are the most popular. This data is used to deliver customized content and advertising within Millennial Destinations to customers whose behavior indicates that they are interested in a particular subject area.

Google Analytics - is a web analytics service offered by Google that tracks and reports website traffic, currently as a platform inside the Google Marketing Platform brand.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Millennial Destinations. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Millennial Destinations website.

Use of Cookies

The Millennial Destinations website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Millennial Destinations pages, or register with Millennial Destinations site or services, a cookie helps Millennial Destinations to recall your specific

information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
